2. Immediately prior to the effective time of the Merger (the "Effective Time"), each share of Class A Common Stock was cancelled and exchanged for \$31.00 per share

3. Each restricted stock unit ("RSU") represents a contingent right to receive one share of Class A Common Stock.

4. The RSUs will vest in full on June 7, 2025, subject to the reporting person's continued service as a Director.

5. At the Effective Time, each unvested RSU was cancelled and converted solely into the right to receive a cash payment of \$31.00 per share of Class A Common Stock subject to such unvested RSU, subject to the terms and conditions of the Merger Agreement.
